## Suspension of legal terms and time periods of the Ministry of Environment and Natural Resources is lifted

On August 24, 2020 the Ministry of Environment and Natural Resources ("SEMARNAT") published the "<u>Ruling</u> <u>lifting the suspension of legal terms and time periods in the Ministry of Environment and Natural Resources and its</u> <u>Administrative Agencies</u>" ("**Ruling**") in the Federal Official Gazette.

The Ruling lifts, as of August 24, 2020, the suspension of legal terms and time periods for purposes of filings, procedures and services before SEMARNAT and its administrative agencies, which were suspended through the various Rulings published in the Federal Official Gazette on May 29, June 4 and July 2 of this year.

All the filings and procedures submitted before SEMARNAT during the period established in the above referenced Rulings will be understood as filed for all legal purposes on August 24, 2020.

In order to prevent the concentration of people in the areas that provide services to the public and continue adopting the necessary measures to preserve the health and integrity of public officers and members of society, the filings, procedures and petitions before the administrative offices and agencies of SEMARNAT may be carried out according to the following days and times:
